

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2020 relating of the Parish of Thriplow and Heathfield

Made 4th day of September 2020

Coming into force in accordance with article 1(2)

South Cambridgeshire District Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 14 July 2020:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by section 86 and 240(10) of the 2007 Act.

Citation and commencement

1. (1) This Order may be cited as the South Cambridgeshire District Council (Reorganisation of Community Governance) Thriplow and Heathfield Order 2020 relating of the Parish of Thriplow and Heathfield.

(2) Article 3 shall come into force on the ordinary day of election of councillors in May 2022.

(3) Article 5 shall come into forces on the day after this Order is made.

Interpretation

2. In this Order

“district” means the district of South Cambridgeshire.

“map” means the map marked “South Cambridgeshire District Council (Reorganisation of Community Governance) Thriplow and Heathfield Order 2020” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

Parish Elections

3. (1) The election of all parish councillors for the parish of Thriplow and Heathfield as shown on the map shall be held on the ordinary day of election of councillors in May 2022.

(2) The term of office of every parish councillor elected on the ordinary day of election of councillors in 2022 for the parish of Thriplow and Heathfield shall be 4 years and their term of office shall thereafter be every four years to coincide with the election of district councillors in South Cambridgeshire and of parish councillors for all other parish councils in South Cambridgeshire.

(3) Where any provision of an Order made before the making of this Order requires an election of parish councillors for Thriplow and Heathfield to be held on a date other than that for which paragraphs 3(1) and 3(2) provide, it shall cease to have effect to that extent.

Number of Parish Councillors for the Parish of Thriplow and Heathfield

4. The number of Councillors to be elected for the Parish of Thriplow and Heathfield shall be 9 in total of which 5 shall be from the Thriplow village ward and 4 shall be from the Heathfield ward.

Change of parish name

5. The parish of Thriplow shall be named the Parish of Thriplow and Heathfield.

Order date

6. In respect of paragraph 5 above the order is effective from the 1st day of April 2021 and for all other paragraphs the 1st day of April 2022, for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

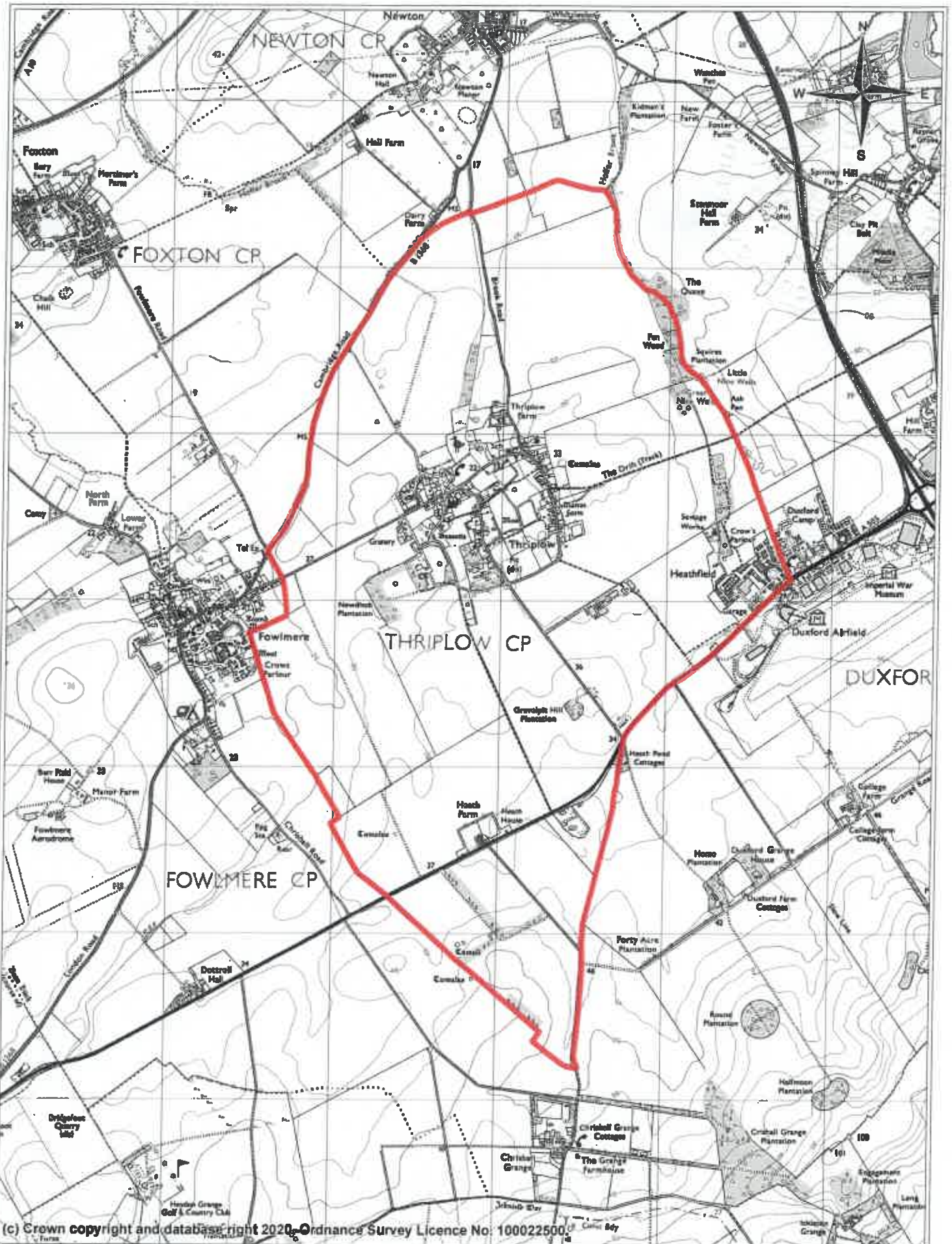
